5. All correspondence will be sent to Client's e-mail address indicated above, and the Client accepts that any correspondence sent from such e-mail address will be treated as mail sent from Client. The Client is obliged to inform the Depositary about changing e-mail address. In case of failure to do so, the delivery of the correspondence to the indicated e-mail address is considered as valid.

6. The following Personal Data of Client/Proxy will be collected and processed by Depositary: name and surname, place of residence, address, date of birth, telephone number, e-mail address, passport number, company data, biometric data (image, fingerprints) and other data as may be necessary for the performance of the Rental Agreement.

7. Amendments of this Rental Agreement must be made in writing otherwise shall be null and void.

8. This Rental Agreement shall be drawn up in two (2) counterparts one for each party.
